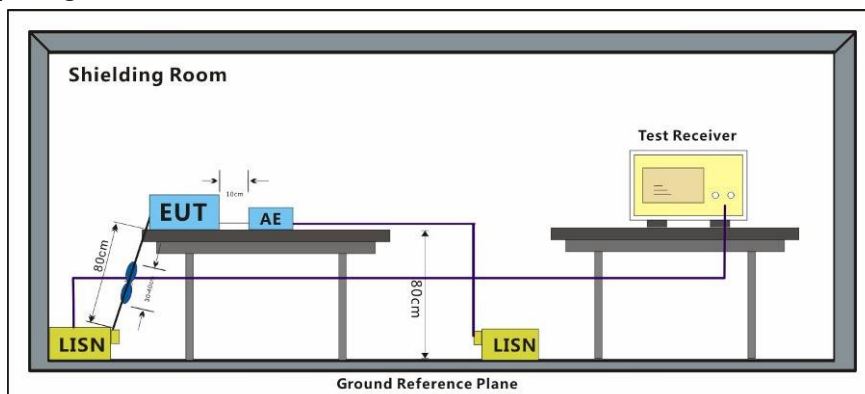

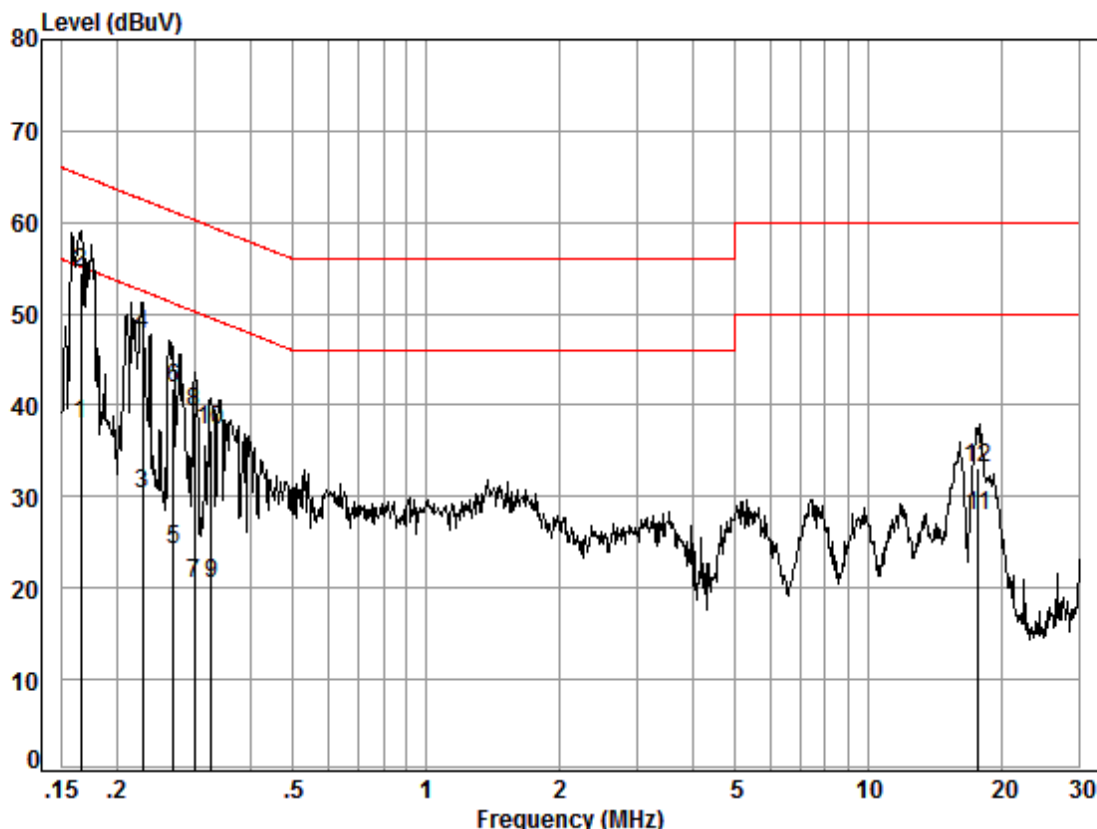
6.1.2 Test Setup Diagram

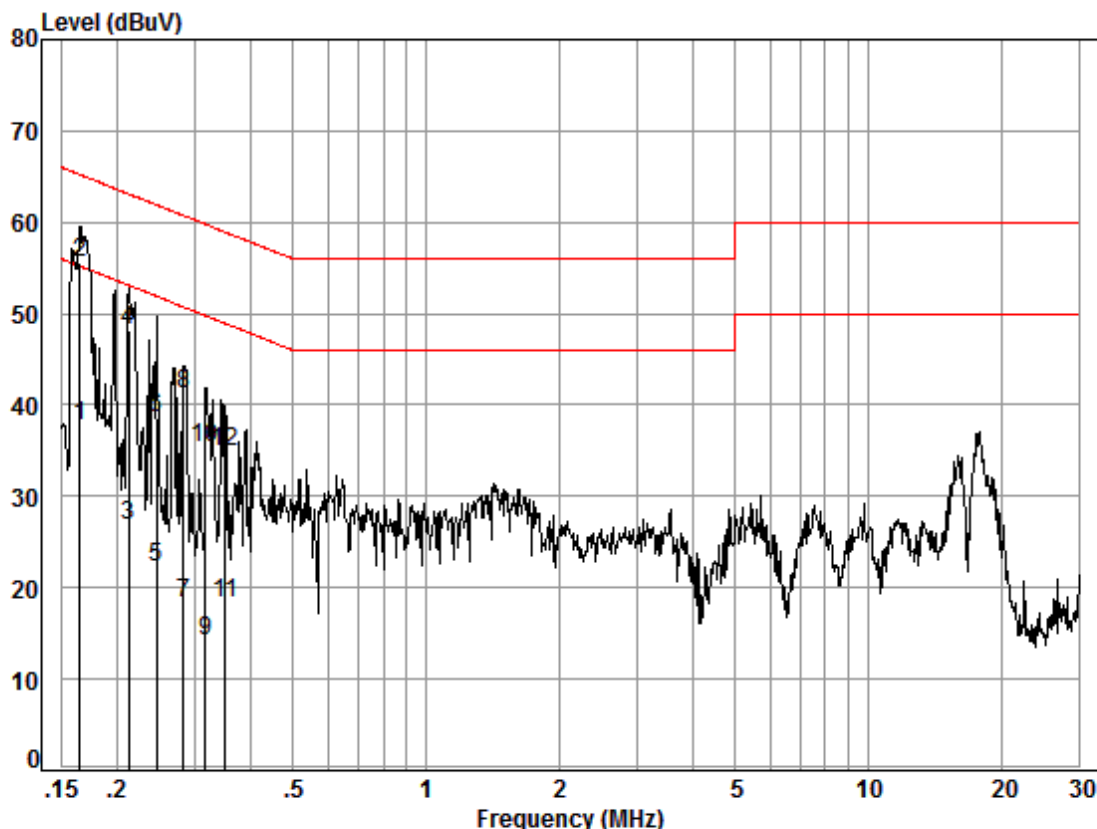

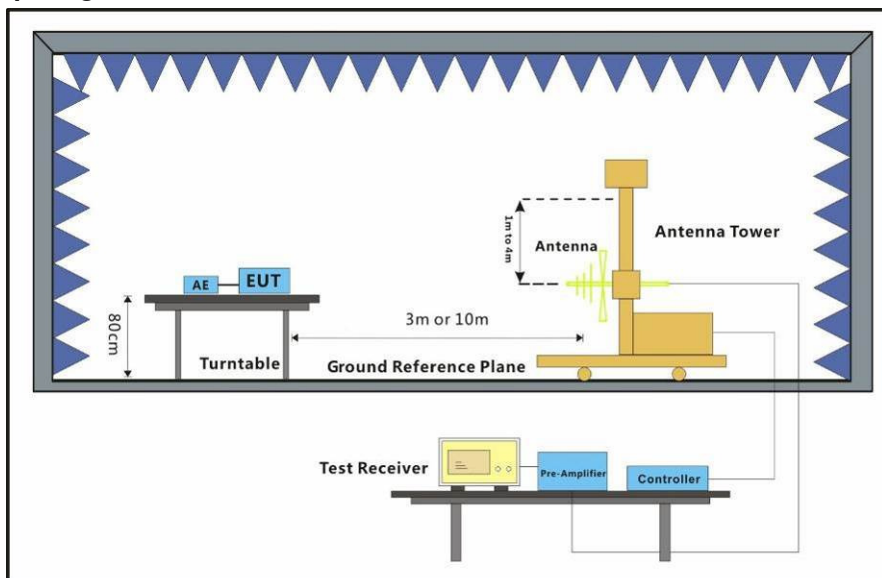

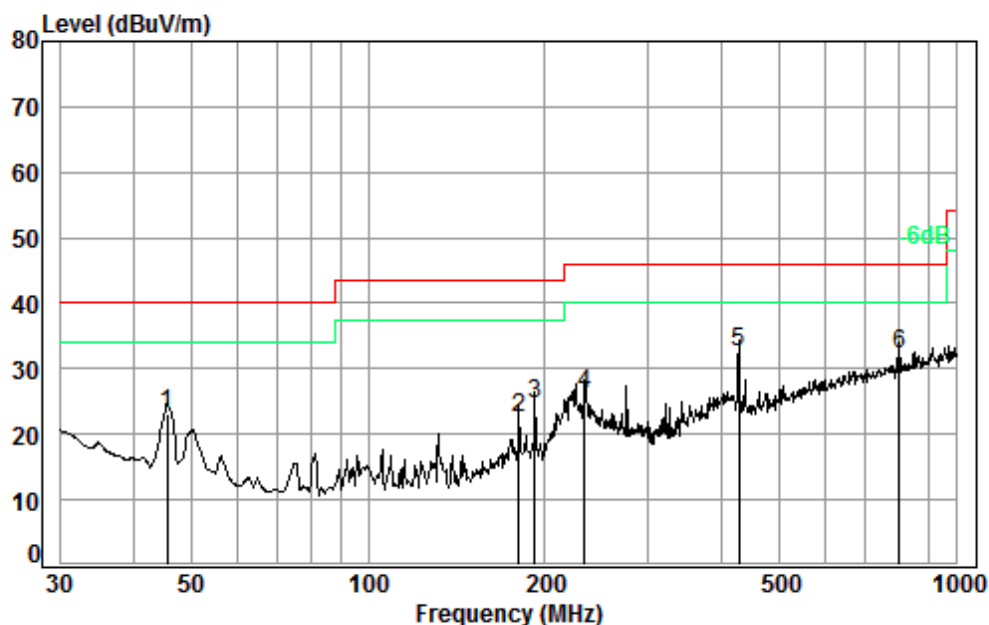
6.2.2 Test Setup Diagram

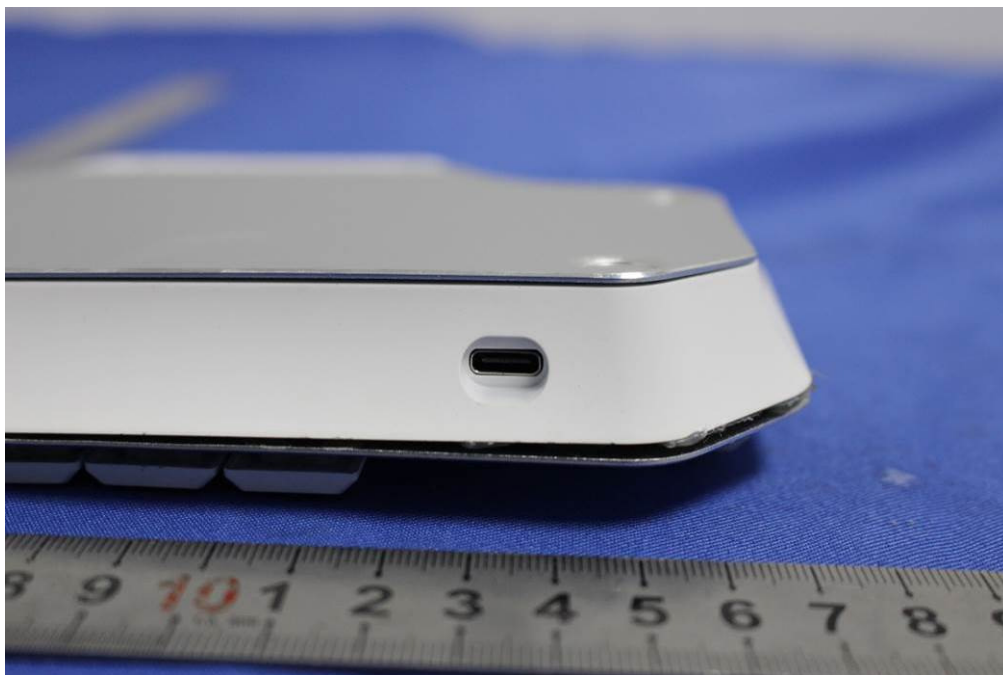
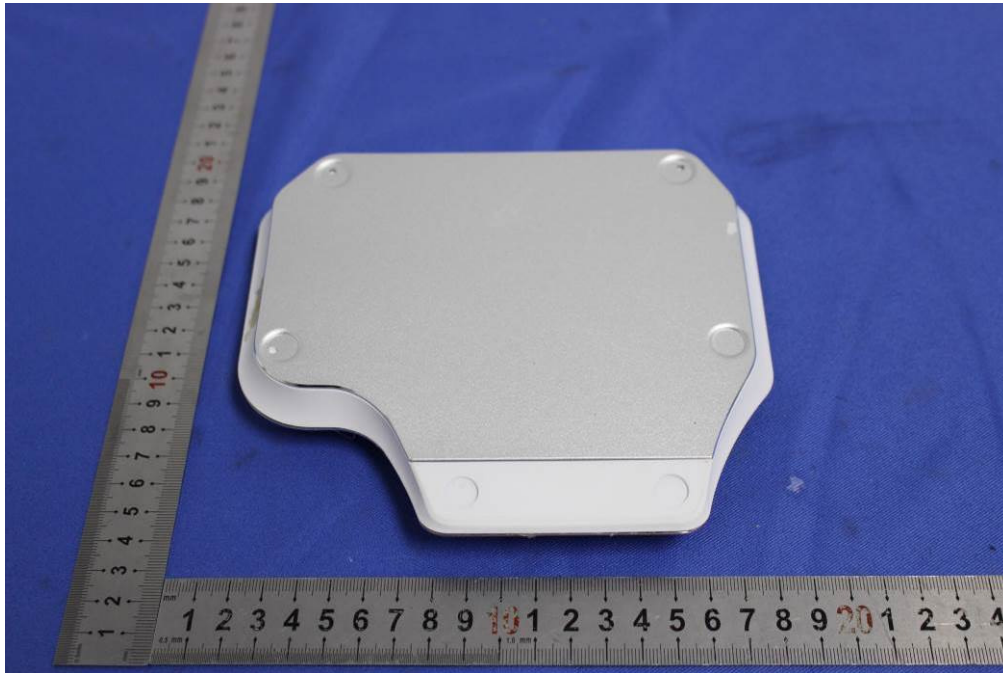


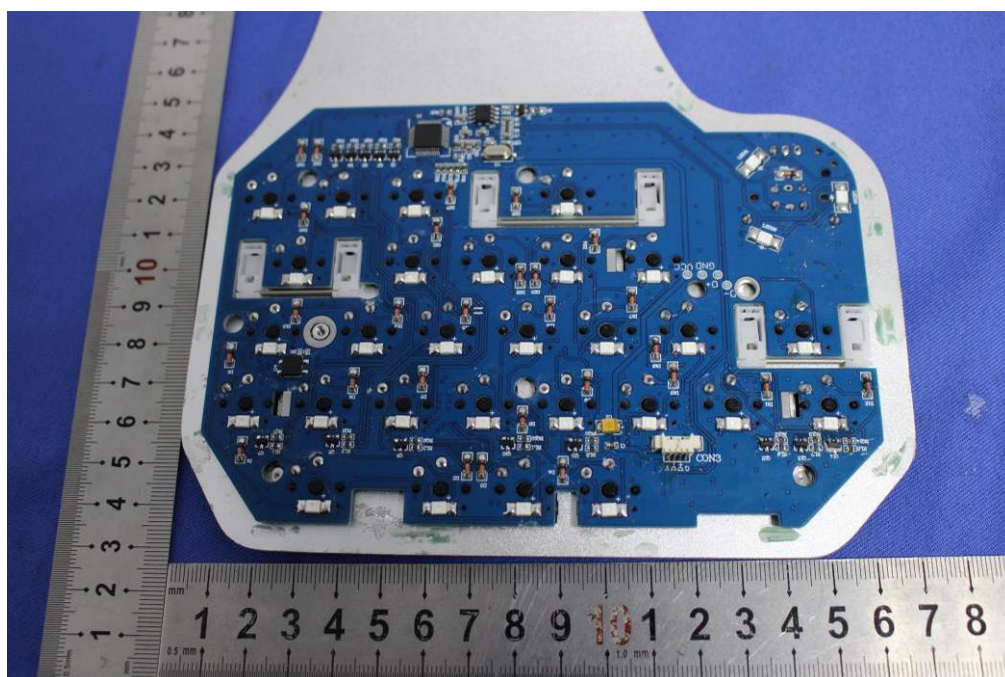
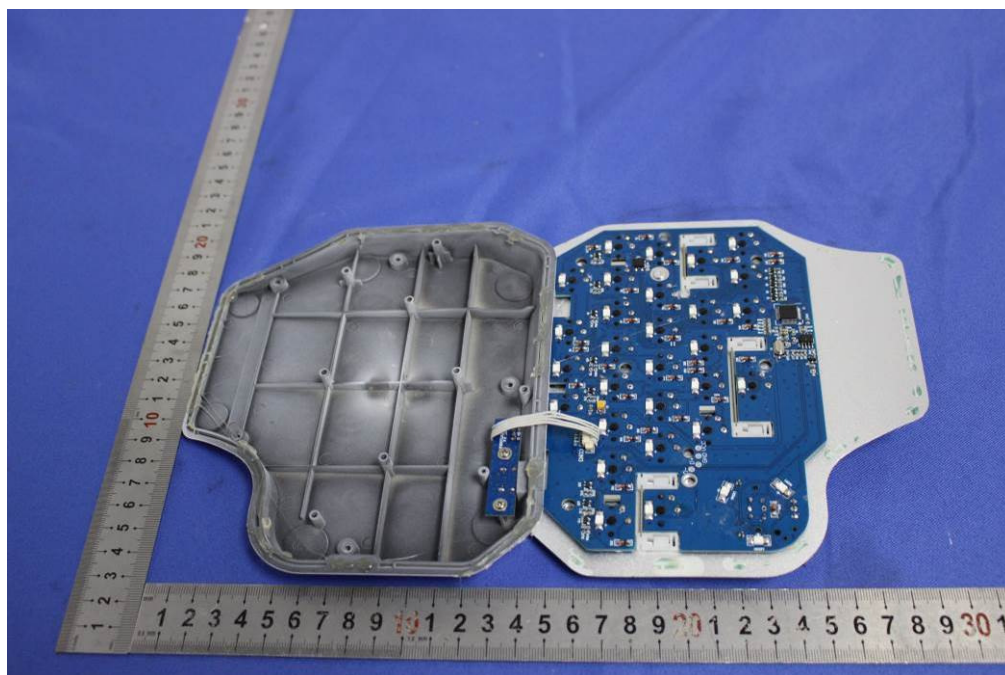
7.2 Radiated Emissions (30MHz-1GHz) Test Setup

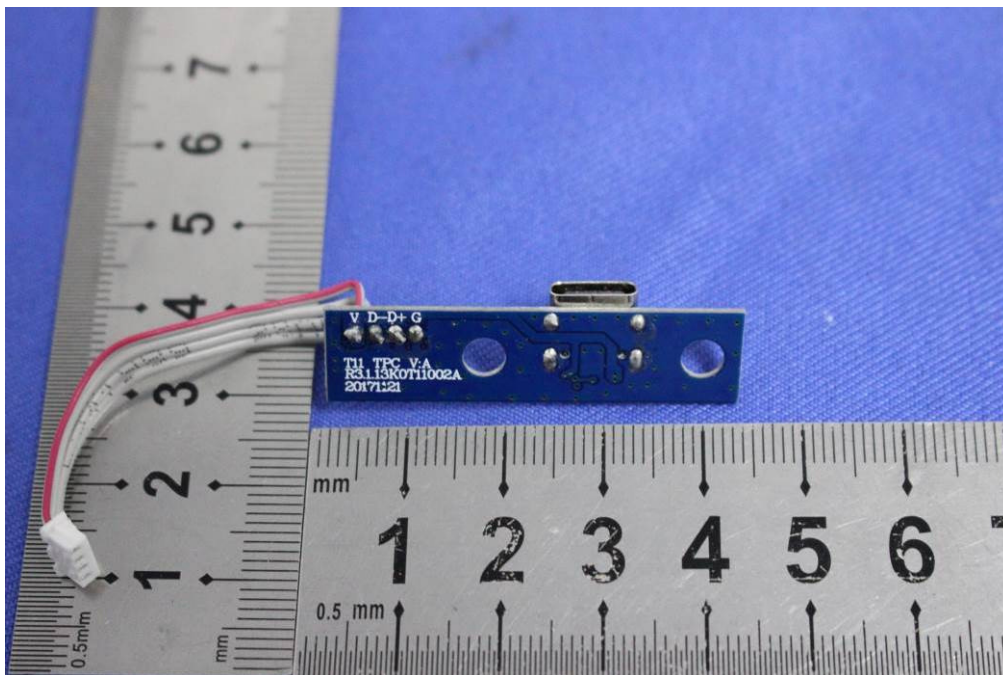
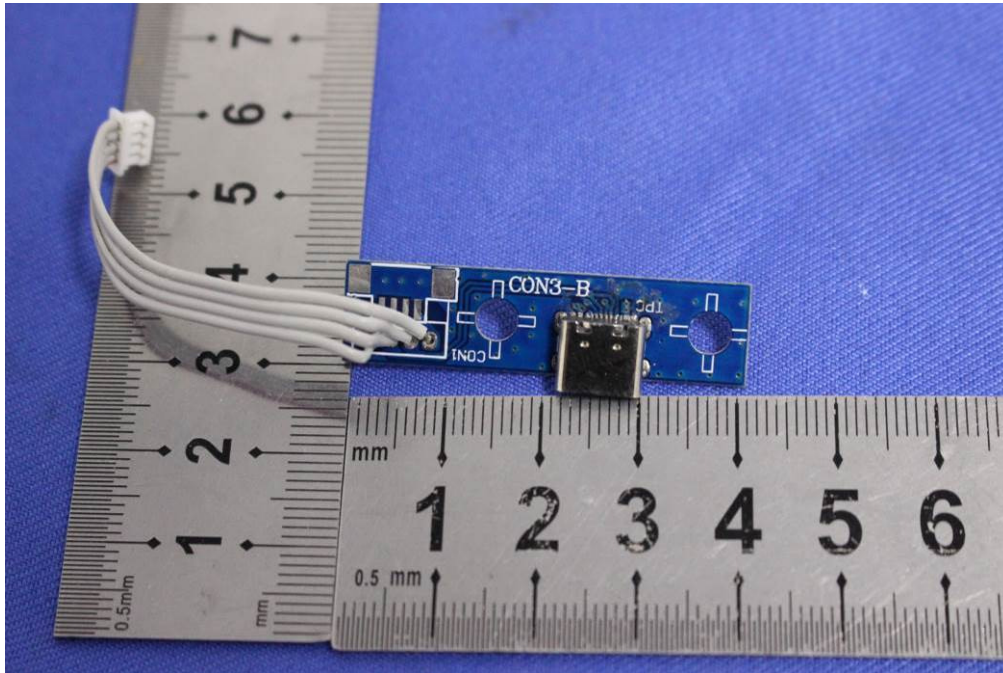
